### **2. Purpose and legal basis of the processing of your data**

your data is being collected in order to provide you with a virtual exhibition / event hosted by the Stadtgalerie Saarbrücken. To make this possible, we are using the open source Software Hubs of the Mozilla Foundation.

The processing itself is based on Art. 6 para. 1 lit. e DSGVO iVm. §4 para. 1 SDGS.

### **3. The categories of personal data,**

their collection, storage, type and purpose of processing are the data which you entered when joining the virtual space. Furthermore, the data required for interacting in the virtual world will be processed, which includes, in addition to the data for your avatar, your audio data, if applicable, which you can activate for this purpose.

### **4. A transfer of your data**

to third parties will not take place, unless it is absolutely essential for the operation of the platform.

### **5. Storage duration**

After the collection, your data will be stored by the responsible entity for as long as it is necessary for this task fulfillment, in compliance with the legal retention obligations.

### **6. Your affected rights**

According to the DSGVO you have the following rights:

- To receive the information about personal data that has been collected about you, in case your data is processed (Art. 15 DSGVO).
- If incorrect personal data is processed, you have a right to correct it (Art. 16 DSGVO).
- If the legal requirements are met, you may request the deletion or restriction of the data processing as well as object to the data processing (Art. 17, 18 and 21 GDPR).
- If you have consented to the data processing or if there is a contract for data processing and the data processing is carried out with the help of automated procedures, you may have a right of data transfer (Art. 20 DSGVO).

If you make use of your above-mentioned rights, the public entity will check whether the legal requirements are met.

Furthermore, you have the right to submit a complaint to the Independent Data Protection Center Saarland.

### **7. Right of revocation**

If you have consented to the data processing, by a corresponding declaration, you can revoke your consent at any time for the future. The lawfulness of the data processing carried out on the basis of the consent until the point of revocation, is not affected by this.
